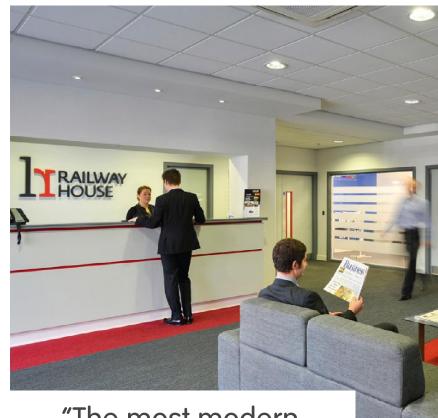


Refurbished and redeveloped, Railway House offers the most modern and flexible office accommodation in the city.

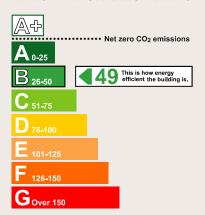

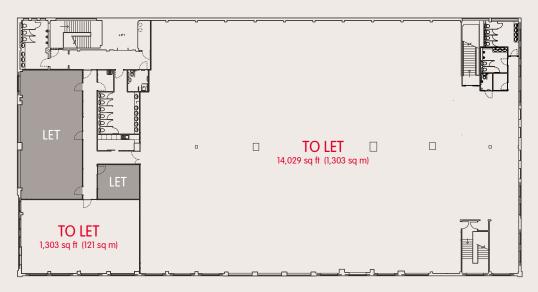

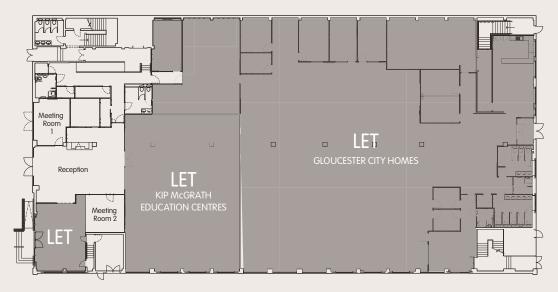
